- Panels, hands-on workshops, action rooms



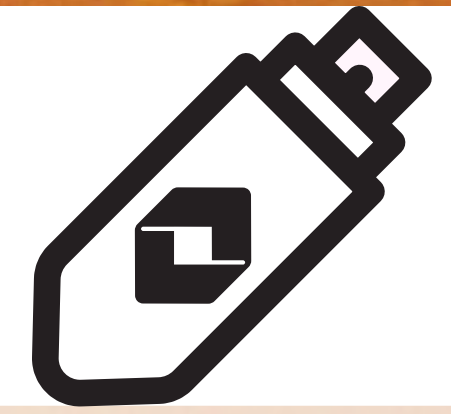

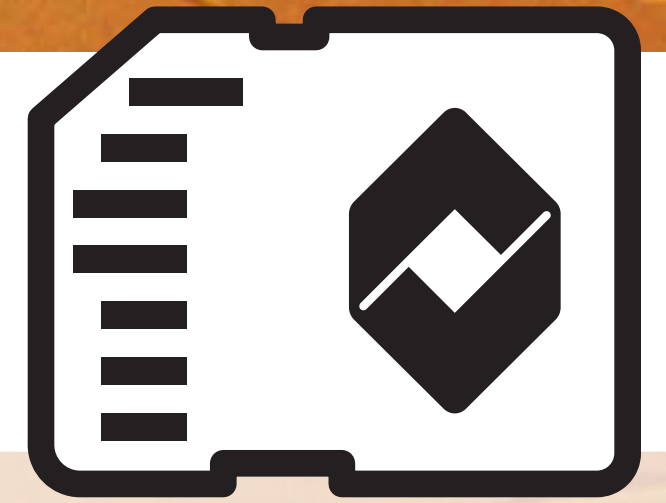
